Garden Waste Collected at Civic Amenity Sites

The collection of garden waste at civic amenity sites offers a relatively low-cost option that diverts substantial amounts of waste away from landfill, thereby helping Ireland meet the EU Landfill Diversion targets.

Using the Environmental Protection Agency's National Waste Reports from 2006 to 2011, Cré have collated data on the tonnes of organic waste (food and garden) collected at civic amenity sites in each county (see Table 1). The EPA reports do not differentiate between food and garden waste. However, Cré is making an assumption that the majority of this waste is garden based.

The Department of Environment, Community and Local Government published a Circular (WPPR 17/08) in 2008. In the circular it stated that it was policy to provide for the collection of green waste at civic amenity sites.

The trends are:

- The following counties collected garden waste at their civic amenity sites in 2011- Carlow, Cavan,
 Clare, Cork, Dublin, Dunlaoghaire, Fingal, Galway County, Kerry, Laois, Limerick County,
 Longford, Louth, Meath, Offaly, South Dublin, Sligo, Waterford City and Westmeath
- The following counties do not collect garden waste at their civic amenity sites in 2011- Galway City, Kilkenny, South Tipperary, Wexford and Wicklow.
- Some counties collect a very nominal amount of garden waste in 2011 Donegal, Kildare, Leitrim, Mayo, North Tipperary, Roscommon and Waterford County.
- The total national tonnage of garden waste collected in 2011 has decreased by 54% compared to 2006 (27,308t to 17,511t).

Cré recommends that:

- not all the Waste Management Plans (Table 2) encourages garden waste collection at civic amenity sites, therefore Cré recommends that the new Waste Management Plans encourages garden waste collection.
- the Department of Environment, Community and Local Government (DoECLG) consult the providers of civic amenity sites on the reasons for not providing the collection of garden waste.
- The DoECLG should provide solutions to issues that providers have in not providing this service.

Circular WPPR 17/08, JULY 2008

The Department of Environment, Community and Local Government published a Circular (WPPR 17/08) in 2008. In the circular it stated that it was policy to provide for the collection of green waste at civic amenity sites.

Extract from Circular 17/08:

- 17.2 Local authorities are encouraged to provide facilities at civic amenity sites for the reception of green waste for centralised composting. While some civic amenity sites accept such materials, many do not. Space constraints apply in some facilities, however there are a number of technologies that can be employed to provide take back of green waste even in relatively small sites. The provision of such facilities is necessary, even in areas where segregated collections are proposed, to ensure that as wide a range of options as possible are available to householders to divert the greatest quantities of biodegradable material to recycling.
- 17.4 In this context, all new or extended civic amenity sites should include provision for the acceptance of green waste from householders destined for centralised composting. Given that the costs associated with the provision of such a service are significantly lower than those relating to source segregated collections at kerbside and in light of the overarching need to divert this waste from landfill, local authorities should provide such a service free-of-charge or at a notional fee in order encourage householders to avail of the additional capacity for green waste diversion.
- 17.5 The Department will prioritise the allocation of future funding towards schemes which, in accordance with the relevant waste management plan, are designed to increase the level of biological treatment of organic waste arising within the municipal waste stream. In particular, support will be provided for -
 - cost-efficient systems for the reception of green waste at civic amenity facilities and recycling centres
