National Waste Prevention Programme (www.nwpp.ie)

- delivering substantive results in preventing and minimising waste.
- aims to bring about waste prevention through programmes and initiatives to promote sustainable consumption behaviours and resource efficiency
- Led by EPA in partnership with key stakeholders and prevention partners
- cited as best practice by EU Commission and OECD.

Local Authority Prevention Network – some background

- began as a demonstration programme in 2006 (LAPD)
- aimed to show that local authorities could design and implement effective local integrated waste prevention programmes and projects
- support provided by way of direct technical expertise and grant monies



Aims of programme

- Development of resource efficiency & waste prevention expertise in local authorities
- Core of staff with prevention expertise within the LAs
- Continued promotion of waste prevention locally
- Fostering formal & informal collaboration between local authorities
- Successful demonstration of savings opportunities, techniques & best practice

Local Authority Prevention Network

Waste Framework Directive (2008/98/EC)

- "waste prevention should be the first priority of waste management"
- "The following waste hierarchy shall apply as a priority order in waste prevention and management legislation and policy:
 - (a) prevention;
 - (b) preparing for re-use;
 - (c) recycling;
 - (d) other recovery, e.g. energy recovery; and
 - (e) disposal."

Legislative & policy provisions

- The transposition Regulations (SI 126 of 2011) make the EPA the competent authority to establish waste prevention programmes (must be in place by December 2013)
- Also make it a legal requirement for local authorities to provide for waste prevention measures in their Regional Waste Management Plans.

Legislative & policy provisions (cont.)

- DECLG 2012: A Resource Opportunity—
 - 'all local authorities, whether acting alone or in groupings, will be expected to participate in the local authority waste prevention demonstration programme, which provides the skills to develop waste prevention within local communities.'
- DECLG & CCMA 2012: Supporting Economic Recovery and Jobs – Locally—
 - Contains a number of references to the work that local authorities are doing through LAPN and NWPP, and to the role of promoting waste prevention and resource efficiency in supporting local enterprise.

Why local authorities?



- LAs have extensive experience in successfully promoting recycling locally
- Using this experience, LAs can work to encourage organisations up waste management hierarchy to waste prevention and reduce resource use
- Prevention needs to be embedded in the community, and local authorities are ideally placed to promote this
- LAs are easily and locally accessible, they know local conditions and issues very well



Considered best practice

- Considered best practice internationally (EC website)
- Has received favourable mention in various reports including OECD Environmental Performance Review, EU consultancy reports





How does LAPN help the local authorities?

- LAPN provides expert technical support to assist LAs in the development and implementation of their programmes
- Financial support to give existing staff the time and space to develop programmes and to learn about waste prevention and resource efficiency & develop expertise



Certified training course

42 people have received training on waste prevention and resource efficiency by attending the HETAC course developed



70% diversion from landfill

Clarenbridge Oyster Festival (Galway Co. Co.)





70% Diversion from Landfill

- 1200 kg of Food Waste and Compostable Products
 - Food waste
 - Compostable Products
 - Oyster shell
- 1300 kg of Recyclables
 - Glass
 - Cardboard
 - Plastics
- 1000 kg of Landfill
 - Carpet
 - Mixed waste



Cliffs of Moher Visitor Centre (LCK Region LAs)

- Segregated bins
- Compostable plates and cutlery
- Portion control
- Leftover reuse in soups, sauces, smoothies, etc.
- Better focus on peak time requirements



Limerick Clare Kerry Regional Waste Office





	Before	After
Waste:	52% recycling	99% recycling
Water:	14,612,000 litres	6,705,000 litres
Energy	2.23 kWhr	1.87 kWhr

Midleton Food Festival (Cork Co. Co.)

- Segregated bins volunteers manning the waste stations
- o General green awareness campaign free notepads were given to shoppers to encourage use of a shopping list when going shopping and also to promote the reduction of food waste; shopping bags with food waste prevention tips





Midleton Food Festival (Cork Co. Co.)

- Stall holders were asked to try to use compostable products and implement other sustainable practices (awarded Midleton Food & Drink Festival Green Member Flag) – many used biodegradable cutlery and eating utensils on the day
- Also opportunity to discuss waste
 reduction techniques with the stall holders
 resulted in much less waste being
 generated at the 2011 festival compared
 to other years.

Midleton Food Festival (Cork Co. Co.)

- Segregated bins -a big challenge on the day to encourage people to segregate their waste correctly
- In 2010 free 1000 L residual wheelie bins provided by service provider. All waste collected going to landfill.
- In 2011, 39% of street waste diverted from landfill (23% food waste & 16% dry recyclables)

Food Waste Prevention in Events and Festivals

Step 1: Green plan

Encourage Food Providers to

- Only use compostable consumables such as biodegradable cups and plates
- Replace burger boxes with a paper envelope and serve products such as chips in paper bags
- Reduce packaging by using reusable trays and boxes
- Avoid single portions of condiments such as ketchup by using refillable containers

- Avoid non-edible garnishes
- Source local and seasonal produce
- Support Fair Trade or other similar schemes
- Clean up in accordance with Site Manager requirements



Food waste regulations: 'compliance assistance'

- Food Waste Regulations driver for information and assistance with food waste prevention
- 'We don't generate much food waste...'
- Segregation highlights this is not true
- Link prevention message with enforcement activities
- Prevention makes business sense & not always involving technological changes
 - Role for LAs to support local business & enterprise
 - Working together creates efficiencies
